## Legal Immigration in Numbers: August 2025 Status Update [download]

While President Trump has kept the spotlight on illegal immigration, legal immigration has also been disrupted—through policy changes and bureaucratic slowdowns. At the same time, delayed data releases have obscured how federal agencies are currently operating, limiting public insight. Below, I analyze the most recent data available, current as of August 25, 2025.

### **U.S.** Citizenship and Immigration Services

U.S. Citizenship and Immigration Services (USCIS) oversees the administration of legal immigration by adjudicating applications and petitions for benefits such as work authorization, citizenship, and legal permanent residence (green card status). Comprehensive processing data for all USCIS forms is only available through March 2025, but a smaller dataset provides updated details through July.

#### Key takeaways from the July 2025 USCIS processing data:

- Consistent with <u>reported pauses</u> in refugee and asylum green card applications, case completions in these categories have decreased sharply since January.
- In other categories, such as petitions for alien relatives and family-based green cards, USCIS completed more cases in July 2025 than January.
- Processing times varied for the reported forms with green card applications for beneficiaries of the Cuban Adjustment Act seeing the sharpest increases, including a 40% increase over January 2025 and a 63% increase compared to the same time last year.

For all USCIS forms, processing data is only currently available through the second quarter of fiscal year 2025, or January through March 2025.

## Key takeaways from the FY2025 Q2 USCIS data:

- In Q2, USCIS completed just 2.7 million cases—down nearly 18% from the 3.3 million completed during the same quarter last year. Completions also fell 12% compared to Q1, underscoring a sharp slowdown in processing.
- Employment authorization applications for DACA recipients saw a 100% increase in processing time from Q1 to Q2.
- The median processing time for Form I-129—the petition used for most temporary, employment-based visas—rose more than 25% since Q1 and is now over 80% higher than it was a year ago.
- Form I-90, the application to replace a green card, saw the steepest spike in delays. Its median processing time jumped 938% in a single quarter—from about 0.8 months in both FY2024 Q2 and FY2025 Q1 to more than 8 months by the end of FY2025 Q2.

Real-time USCIS processing data isn't easily accessible in aggregate, but annual median processing times still offer valuable insight into broader trends.

**Key takeaways from the FY2025 Median Processing Times:** 


- The FY2025 median processing time for Form I-90, the application for a replacement green card, increased by 471% between January 31, 2025 and June 30, 2025.
- The median processing time for DACA employment authorizations and DACA renewals increased by 50% between January 31, 2025 and June 30, 2025.

Across all reported form types, FY2025 median processing times increased by an average of 11.1% between January 31, 2025 and June 30, 2025. Setting aside the 471% surge in I-90

processing times, median processing times for all other reported form types in FY2025 rose by an average of just 1.3%.

#### **Department of State**

The Department of State (DOS) issues visas to foreign nationals abroad, leveraging interviews and other vetting tools to protect the integrity and security of legal immigration.

#### Key takeaways from consular wait times

• Consular wait times have fluctuated sharply in recent months as new requirements—such as social media reviews and other vetting measures—have taken effect. While

some posts have actually managed to lower wait times in spite of these changes, other locations have seen steep increases in estimated wait times.

- o Among reported posts, visitor wait times increased by an average of 69% between January 7, 2025 and August 18, 2025.
- o Student wait times increased by an average of 259%.
- o Petition-based wait times increased by an average of 187%.
- o Transit and crew wait times increased by an average of 110%.
- New interview waiver guidelines are taking effect on September 2nd and are likely to increase wait times further. For more context, check out "Interviewing Babies: The Latest in Consular Inefficiency."

*Note*: Between January 2025 and April 2025, the Department of State consular wait time data changed formats. Data that was once reported in days is now published only in rounded months. For consistency, January 2025 figures have been converted into approximate months to allow comparison.

Key takeaways from the consular visa issuance statistics

- U.S. consulates issued 16% fewer nonimmigrant visas in May 2025 than in May 2024.
- By magnitude, the largest decreases in NIV issuances occurred among visitor visa types B-1, B-2, B-1/B-2, BBBCC, BBBCV with a cumulative decrease of 136,025 and F-1 student visas with a decrease of 12,689, compared to May 2024.
- U.S. consulates issued 20% fewer immigrant visas in May 2025 than in May 2024.
- By magnitude, the FX classification for country cap-exempt immediate relatives of green card holders experienced the largest decrease in IV issuances as U.S. consulates issued 6,128 fewer FX visas in May 2025 compared to May 2024.

## **Department of Labor**

The Department of Labor (DOL) oversees multiple labor certification and prevailing wage processes that were designed to protect American workers and uphold minimum standards for the employment of foreign nationals sponsored on employment visas.

## Key takeaways from the PERM processing times

- PERM processing times began rising steadily well before the change in administration. From March 2025 and July 2025, processing times actually leveled off, holding at roughly 500 days for several months.
- In late June, the Trump administration created the Office of Immigration Policy within the Department of Labor to steer immigration priorities and resources. It remains unclear whether this new office will take steps to reduce PERM delays.

## **Immigration and Customs Enforcement**


Beyond leading the interior enforcement efforts, Immigration and Customs Enforcement (ICE) also administers SEVIS, (the Student and Exchange Visitor Information System used by international students and cultural exchange visitors).

#### Key takeaways from the SEVIS records

- Although international student enrollment is <u>expected to decline</u> significantly this fall, the monthly SEVIS data does not yet show that trend. In fact, August 2025 recorded more than 41,000 additional active SEVIS records compared to August 2024.
- This dataset also does not appear to reflect the termination of <u>more than 1,800</u> SEVIS records earlier this year—likely because most have since been reinstated.
- Notably, in July 2025, SEVIS data was re-released after a prior deletion. The new data varies significantly from the data available prior to April 25, 2025. For a review of what changes were made, read "ICE rewrites international student data without explanation."


The National Travel and Tourism Office, part of the International Trade Administration, tracks data on international travel to and from the United States.

## Key takeaways from the overseas visitor numbers

- Over 300,000 fewer overseas visitors came to the U.S. during the first 7 months of 2025 compared to the same time period in 2024.
- February 2025 marked the first month with a year-over-year decrease in overseas visitors since the COVID-19 pandemic.
